



[The Jean Monnet Centre of Excellence on the Integration of Migrants in Europe \(IntoME\)](#) has been established in September 2020 at the Department of Modern Languages and Literatures, History, Philosophy and Law Studies (DISTU) of Tuscia University (Viterbo, Italy). It aims to be **an education and research platform on migration and asylum processes**, with a special focus on integration matters. IntoME promotes excellence in its research and teaching activities, by **connecting networks of academics and high-level experts** with strong competence in immigration, asylum, integration, inclusion, and participation studies. The Centre of Excellence is committed to **establishing synergies with other Jean Monnet modules and centres** working on issues of common interest (inter alia) by inviting their staff members to take part in IntoME activities and actively engaging in other JM projects. Furthermore, the Centre of Excellence is connected to the **Academy of Law and Migration (ADiM)**, created in 2018 as a result of the Project of Excellence (2018-2022) awarded to the DISTU Dept. by the Italian Ministry of Education and Research (MIUR) for the quality of its scientific publications in the public law area. With its 460 members, among Italian and European scholars, and 20 institutional partners, from Europe and North Africa, **ADiM is a consolidated forum supporting IntoME activities**, especially in the search for new avenues of collaboration with academic institutions in Europe and beyond.

ADiM-IntoME's new Laboratories

- a) The Laboratory on *[Protected Entry Procedures \(VIP Lab\)](#)*, coordinated by Luca Galli, Francesco Gatta, Cecilia Siccardi and Mario Savino, aims to study different types of legal pathways for international protection seekers in a European and comparative perspective. The [kick-off meeting](#) was held on the **24 January 2023**. A second meeting (on **17 February**) paved the way to the elaboration of the Lab's two-year programme of activities. The **next meeting** is scheduled to take place on **Wednesday 29 March** at **5.30 p.m.** (Zoom platform).
- b) The Laboratory on ***Migration & Tech (MET Lab)***, coordinated by Erik Longo, Simone Penasa, Graziella Romeo and Mario Savino, aims to study the impact of new **technologies** in the regulation of migration flows, focusing on the legal implications and regulatory options. The [kick-off meeting](#) was held on the **25th of January**. A second meeting (on **21 February**) was dedicated to identifying the specific areas of research. The work of the group will be conducted over a two-year period of 2023-2024. The **next meeting** is scheduled to take place on **Wednesday 5 April** at **5.30 p.m.** (Zoom platform).
- c) The Laboratory on ***Constitutional Jurisprudence on Migration and Asylum (COST Lab)***, coordinated by Marco Benvenuti, Francesca Biondi Dal Monte, Giacomo D'Amico and Mario Savino, was launched on [7th February 2023](#), with the aim of strengthening the dialogue between the Italian Constitutional Court and the academia. The COST Lab will carry out **three main activities** in 2023: i) organization of periodic seminars on relevant case-law; ii) elaboration of opinions related to pending cases in the capacity of Amicus Curiae; iii) launch of an inter-university moot court programme. During the [next meeting](#), scheduled on **Wednesday 15 March** at **5.00 p.m.** (Zoom platform), the details of the Inter-University Moot Court Initiative (GIUSI) will be presented.
